In conjunction with the above referenced school, the award for training will be given to qualified applicants for up to a maximum lifetime benefit of one thousand dollars per person for tuition only. Applicants are responsible for any textbook or additional fees. If you drop out of the program or change your mind, there will be no refund of any money you paid or any portion of the award remaining. There are no exceptions to this refund policy and this supercedes any refund sections provided for on the school's website, printed materials or elsewhere. There will be no financial penalty assessed should you drop out either. Applications received after the start of the program are not retroactive, they must be received prior to starting. You have one year to complete the program, otherwise any fees paid will be lost and any time spent will be invalidated. You cannot upgrade to a more expensive package if you accept an award no Android Tablet will be included. Since this is part of a NY State licensing series, please do not submit an application if you have ever been convicted of a misdemeanor or felony anywhere in this state or elsewhere. The school requires a satisfactory BACKGROUND CHECK prior to formal acceptance into the program. If you have received a misdemeanor or felony conviction here or anywhere EVER please talk to the school BEFORE completing this application. Applicants that receive an award will have to pay either their entire portion upfront or if splitting it into three payments it would be as follows: \$1,699 Program Cost - \$1,000 (if you receive a full award) = \$699 / 3 = \$233 on day one of the program and \$233 twice more at 30 day increments. The internship portion of the program cannot start until payment in full is received. As part of this application, all applicants must include a written statement explaining how or why he or she feels they would contribute to the field of property management - the statement must be a minimum of 100 words. You will be notified by email of the status of your application within 10 business days. Award recipients cannot start until full payment is made to the School in the form of cash, check or money order only. The 75 hour Real Estate Licensing Course must be successfully completed before any other courses may be started.

I certify that the information provided herein is accurate and complete. I also understand the financial consequences should I later change my mind if I am granted an award.

I know that I am not under any obligation whatsoever by submitting this application and that incomplete applications will not be processed. If I am awarded any funds, register and then do not show up, I am ineligible to ever submit another application again.
